## **CONDITIONS OF TENDER SERVICE**

- Tender service is available to all yachts / powerboats of current paid-up <u>Full</u>
   <u>Adult and Senior Members</u> kept on non-Club moorings in the area of Middle Harbour from Chinaman's Beach to the Spit Bridge and in the Upper Middle Harbour area from the Spit Bridge to Pearl Bay.
- 2. Tender service to these yachts is charged at as per the above table per yacht per annum and covers the member and guests. Casual tender use, including contractor fees may be made available upon payment of casual fee of \$40 incl GST per pick up and return prior to departure, when available.
- Tender Service Fee to yachts on MHYC Moorings is included in permanent Mooring Fees, Contractor fees are additional.
- 4. For the convenience of members and their guests a list of yachts subscribed to the Tender Service maybe posted on the Club's notice board, updated monthly. Tender operators are not authorised to operate to yachts that have not registered for and paid for tender service.
- 5. Tender service hours are published on the Club's notice board and the MHYC Website <a href="http://www.mhyc.com.au/marinatender-service.cfm">http://www.mhyc.com.au/marinatender-service.cfm</a> and vary according to seasonal demand and the Club's Racing Programme. Owners are requested to assist the operator by observing a maximum load of 6 passengers and ensure that all passengers remain seated at all times until tender has safely docked. In the event of bad weather this number may be reduced or tender service may be suspended.

- 6. Tenders or MHYC base may be contacted on VHF Channel 73 to arrange transfers.

- 7. MHYC Tenders operate under NSW Maritime Regulations, Speed limits and Passenger numbers will be enforce at all times (4kt limit). The directions of the driver shall be obeyed at all times.
- 8. MHYC Tenders will only service vessels whilst stationary on their moorings. No vessel underway will be permitted to have Crew or Guests board from the Tender.
- 9. Tender service to Pearl Bay and West of the Spit Bridge operates 30 minutes prior to bridge opening on demand. Please contact MHYC prior to confirm pickup. During peak load passengers may be discharged at Pearl Bay pontoon to speed service.
- 10. Tender service to and from Clontarf Marina is provided free to all financial MHYC members during scheduled hours to ease parking congestion at MHYC.
- 11. Members are encouraged to use Marina T-Heads C and D to collect and drop off passengers and to only take the crew necessary to safely leave/secure their mooring.
- 12. Casual 10 Non transferrable, Non refundable. Valid for 12 months from date of issue. 10 return trips included. One trip is to be completed on same day or a second trip will apply.
