The Organising Authority for this Regatta is the Gosford Sailing Club (GSC) in conjunction with Middle Harbour Yacht Club (MHYC).

1 RULES

- 1.1 The Regatta will be governed by the rules as defined in the current Racing Rules of Sailing (RRS) of World Sailing (WS).
- 1.2 Australian Sailing Special Regulations Category 5 shall apply for the offshore passage races.

2 ADVERTISING

2.1 World Sailing Regulation 20 shall apply.

3 CLASSES AND HANDICAPS

3.1 The event will be sailed in separate classes as follows:

- 3.2 Classes and divisions may be created, amalgamated, divided or abandoned at the discretion of the Race Committee.
- 3.3 Performance Handicap results will be decided by the application of a Time Correction Factor (TCF) as a multiplier of elapsed times. Each boats TCF will be allocated by the Race Committee and will not be subject to protest or request for redress (amends RRS60.1and 62)

4 ELIGIBILITY AND ENTRY

The Regatta is open to yachts that fulfil the following requirements:

- 4.1 Each helmsperson and crew shall be a member of a Club affiliated with their World Sailing Member National Authority.
- 4.2 Each participating boat shall hold a marine legal liability insurance policy with respect to a boat, (Non-Spinnaker Div. boats insurance as per GSC twilight entry insurance requirements) current when racing and not racing with a minimum cover of \$10,000,000. The policy will be in effect throughout the regatta.
- 4.3 Eligible boats may enter by completing the attached form and sending it, together with the required fee, if any to the Gosford Sailing Club prior to 1100hrs on Wednesday 24th of January 2017.

8.1 Sailing Instructions will be available on the GCS & MHYC websites no later than Wednesday 24 January 2018.

9 RACING AREA

9.1 For the inshore races conducted on Brisbane Waters off Gosford Sailing Club, competitors are advised that the water north of the cardinal mark at Point Frederick is extremely shallow.

10 COURSES

10.1 Race courses will be Passage and Windward/Leeward configuration all as described in the Sailing Instructions.

11 SCORING

- 11.1 Magic Challenge 3 races are scheduled of which one 1 completed race are required to constitute the Regatta.
- 11.2 Melges Challenge 3 races are scheduled of which one 1 completed race are required to constitute the Regatta.
- 11.3 The Low points score system as described in appendix A, A4.1

13 ELECTRONIC COMMUNICATIONS

- 13.1 In accordance with rule 41, the Race Committee may broadcast the course to be sailed, names/sail numbers of OCS boats, and/or any other information of interest to competitors. Any failure of, or defect in, such a broadcast will not be grounds for redress. Boats may transmit on VHF radio to communicate in the event of an emergency, upon retiring from a race or at the request of the Race Committee.
- 13.2 This restriction also applies to mobile phones and data communication

14 PRIZES

- 14.1 Trophies may be awarded for first place in the competing class and Team
- 14.2 Prizes may be awarded to the yachts placed first to third.
- 14.3 Other Prizes may be awarded at the Organising Committees discretion
- 14.4 Trophies and Prizes will be presented as soon as practical after the last race of the Series.

15 YACHT BERTHS AND TRAILOR PARKING

- 15.1 GSC and MSC will provide berths or moorings without charge to all competing yachts.

DECLARATION

The Owner/Skipper

- acknowledges that this entry is made subject to the conditions set out in the Notice of Race and Sailing Instructions as may be amended.
- acknowledges that all Racing conducted by the GSC & MHYC will be governed by, and agrees that the boat is bound by, the Rules and regulations specified in the Sailing Instructions, as they may be amended.
- acknowledge and accept the risks, including the risk of harm to persons associated with:
 - (a) the perils of the sea
 - (b) The seaworthiness or otherwise of any boat participating in any Racing organized or conducted be the GSC & MHYC.
 - (c) The participation, including negligent participation, by all persons in Racing organized or conducted by the GSC & MHYC, including participation as skipper, crew person, official, race organizer or otherwise;
 - (d) The defaults, acts and omissions, including negligent defaults, acts and omissions, of Gosford Sailing Club Ltd. and its officers, employees, agents, volunteers and members, and the crews of all boats:
- 4 acknowledge and accept that the GSC & MHYC:
 - (a) does not and cannot control, diminish or affect the perils of the sea;
 - (b) is not in a position to take precautions against the risk of harm to persons arising from the perils of the sea;
 - (c) is not in a position to provide advice, assistance or support to boats and crews during the course of Racing organized or conducted by the GSC & MHYC;
 - (d) Does not certify the seaworthiness or suitability to race of any boat.
 - (a) to release, hold harmless and indemnify the GSC & MHYC and its officers, employees, agents, volunteers and members from all liability any of those persons has to the owner/skipper or any crew member on the boat, or to any person claiming through or under any such person, arising from the loss of life or injury to persons, or loss of or damage to property, howsoever caused, including by negligent act omission, arising out of or relating to:
 - (i) Participation by the boat or any other boat in racing organized or conducted by the GSC & MHYC.
 - (ii) Any matter referred to in paragraphs 3 and 4
 - (iii) the conduct or courses of races in any respect including any act or omission (whether reasonably foreseeable or not) causing or relating to loss of or damage to any boat or the death of or injury to any person.
 - (b) that participation by the boat and crew in any racing organized or conducted by the GSC & MHYC is agreed by GSC & MHYC on the basis that participation is entirely at the risk of the owner/skipper and each member of the crew and that GSC & MHYC is not responsible for the boat or its crew; and
 - (c) it is the sole and exclusive responsibility of each boat to decide whether to start or not to start any racing organized or conducted by the GSC & MHYC or, once having started, whether to continue to race:
- acknowledges and agrees that the contract formed by the acceptance of this entry by GSC & MHYC is governed by the law of New South Wales and that any liability for harm to persons that results from breach of an express or Implied warranty that all Racing organized and conducted by the GSC & MHYC and all services relating thereto will be conducted or rendered with reasonable care and skill is excluded.
- agrees that if the owner/skipper or any person on the owner's/skipper's behalf requests the Race Committee or any officer, employee or volunteer of GSC & MHYC to arrange for special assistance because the boat has become disabled, or for any other reason, them the owner/skipper indemnifies GSC & MHYC and its officers, employees, and agents in respect of any liability, cost or expense which may thereby be incurred.
