

## DEED POLL and STATUTORY DECLARATION - NSW

do solemnly and sincerely declare and agree as follows:

1. I will act as the <sup>3</sup> \_\_\_\_\_ sailing an Adams 10 yacht, to be identified in a draw, in a number of races in an event known as “the Waitangi Cup” (“**the Event**”) conducted under the auspices of the Middle Harbour Yacht Club.
2. I have had experience in that role on an Adams 10 yacht in races conducted by a club affiliated with Australian Sailing (“Affiliated Club”) over a period of<sup>4</sup> \_\_\_\_\_ years and regard myself, and am regarded by my peers, as competent in the performance of that role.
3. I have not been refused insurance of marine craft during the previous five years from the date of this declaration.
4. I will procure that each of the persons comprising crew of the yacht participating in the Event is a registered member of an Australian Sailing Affiliated Club.
5. If the yacht I am sailing during the Event or any of the spars, sails or rigging on that yacht is damaged during the Event and any applicable insurance policy subjects the cost of repairing that damage to an excess amount, I will procure that the costs of repair up to the amount of the excess will be reimbursed to the owner of the yacht upon request by the owner and production of a quote or invoice for such repair.
6. I make this Declaration in consideration of the owner of the yacht making it available for the Event and I intend it to create legal obligations enforceable by the owner.

AND I MAKE this solemn declaration conscientiously believing the same to be true, and by virtue of the provisions of the Oaths Act 1900.
