NOTICE OF RACE

INVITATION TO RACE

Middle Harbour Yacht Club in conjunction with ASX Refinitiv Charity Foundation invites eligible boats to compete in the Financial Markets & Media Markets Charity Regatta 2025.

The Organising Authority is the Middle Harbour Yacht Club (MHYC).

1.0 RULES

- 1.1 The Race will be governed by the following:
 - the Rules as defined in the Racing Rules of Sailing (RRS)
 - the Special Regulations of Australian Sailing (AS)
 - the MHYC Conditions of Entry (attached to this Notice of Race)
- 1.2 The Race will be a 'Pursuit' race with a Handicapped starting sequence.
- 1.3 The Race will be categorized as 'Non-Spinnaker'. Boats shall use only a mainsail and one headsail at any time. The headsail may be poled out but shall be fully hanked or attached by means of a luff groove device to the permanent forestay. Headsails shall not be set flying. No sail shall be attached forward of the point of attachment of the permanent forestay.

2.0 ADVERTISING

- 2.1 Advertising on a boat shall comply with the requirements of World Sailing Regulation 20 (Advertising Code).
- 2.2 The Organising Authority or ASX Refinitiv Charity Foundation may provide sponsor's decals and or backstay flags. A boat shall display the sponsor's name and or backstay flag in accordance with this Notice of Race and the Sailing Instructions.

3.0 ELIGIBILITY AND ENTRY

- 3.1 The Race is open to boats that are a single hulled and self-righting design. All boats entering shall hold and submit the following documentation:
 - a current Category 7 (or higher) AS Special Regulations 'Equipment Compliance Form' or
 - a current Survey Certificate issued by NSW Maritime (RMS);
 - and evidence of Public Liability Insurance cover of no less than \$10,000,000 by way of a Certificate of Currency or Policy document copy;
 - and currently be on the Register of a Sailing Club affiliated with its National Authority.
- 3.2 Eligible boats shall enter by completing the attached Registration Form and signing and dating the 'MHYC Conditions of Entry'.
- 3.3 Registration forms and all above documentation shall be submitted to the ASX Refinitiv Charity Foundation by close of entries.
- 3.4 Close of entries will be 1700hrs on Friday, 7 November 2025.

3.5 The Organising Authority in conjunction with ASX Refinitiv Charity Foundation may, at its discretion, vary these eligibility and entry requirements if it deems that the entry of a boat in this race has the potential to advance the quality of racing in this race.

5.0 SAILING INSTRUCTIONS

5.1 Sailing Instructions will be published by the Organising Authority and available from the MHYC Website www.mhyc.com.au by 1700hrs on Wednesday, 12 November 2025, two days before the Regatta.

6.0 RACING AREA

- 6.1 Racing will be conducted on the waters of Lower Middle Harbour and Sydney Harbour.
- 6.2 The Race will be Started and Finished in the vicinity of Hunters Bay, Balmoral.
- All boats entering shall check they have suitable draft to safely navigate on the waters of Lower Middle Harbour up to and including in front of the MHYC Clubhouse.

7.0 COURSES

7.1 Courses will be Inshore Harbour Passage courses and will be detailed in the Sailing Instructions.

8.0 ALTERNATIVE PENALTIES

8.1 RRS 44.1 Two-Turns Penalty applies for breaking a Rule of RRS Part 2.

9.0 DIVISIONS & HANDICAPS

- 9.1 Divisional parameters will be optimized at the discretion of the Organising Authority or their nominee, based on the entries received. Divisions may be formed or abandoned at the discretion of the Organising Authority.
- 9.2 A List of Entries, Divisions and Starting Handicaps will be published by the Organising Authority and available from the MHYC Website www.mhyc.com.au by 1100hrs on Friday, 14 November 2025.

10.0 PRIZES

10.1 Trophies may be awarded to the first three (3) place getters in each division at a presentation to be held at MHYC following the race.

11.0 DISCLAIMER OF LIABILITY

- 11.1 Competitors participate in the Race entirely at their own risk. The Organising Authority, the ASX Refinitiv Charity Foundation and Sponsor's, including their respective officers, employees, volunteers and members, will not accept any liability for any loss, material damage or personal injury or death sustained in conjunction with or prior to, during or after the race.
- 11.2 The Organising Authority, the ASX Refinitiv Charity Foundation and Sponsors, are not responsible for the seaworthiness of a yacht whose entry is accepted or the sufficiency or adequacy of its equipment.

12.0 BERTHING & MOORINGS

- 12.1 Limited casual berthing and moorings are available to boats competing in this race. All requests for casual berthing and moorings shall be made by completing the 'Casual Berthing Registration' form available from the MHYC Website www.mhyc.com.au.
- On Race Day, berthing on the outer 'T-Heads' of the Marina will not be available. The outer 'T-Heads' will be reserved only for pick-ups and drop-offs for boats needing to facilitate their guests and crew. Competitors are requested to contact the MHYC "Dock Master" on VHF Ch 73 when approaching the Marina to temporarily tie-up for pick-ups and drop offs.

13.0 TENDER SERVICE

On Race Day, the Organising Authority may provide a Tender Service for boats competing in this race who are moored in the immediate vicinity of the Club. A limited service may also be provided to boats in Hunter's Bay who are limited by draft to enter Middle Harbour – strictly by prior arrangement.
